Architectural Description:

The Beckley Feed & Hardware store, built in 1935, is sited a few feet from Prince Street near downtown Beckley. The business was originally located, from 1926-1935, about 200 yards up Prince Street before moving to its present location, having outgrown the existing facilities. Access to the railroad was crucial, and a side line was located next to the building until 1999. The present building consists of two sections, the older portion being constructed in 1935 and an additional wing constructed in 1951. The building retains its original features and all of its original windows.

The older section is two stories, constructed of glazed ceramic block with a flat profile against the street and angled sides. There are loading dock facilities on two sides. A shed awning extends over a door opening. The windows are all multi-light and of wood construction. The roof is built-up with tar, felt and roll roofing.

The 1951 wing was constructed to expand the hardware sales department. The wing is one story in height with a brick façade and a wall of windows made up of horizontal lights. A center double door leads into the building. On the roof is a parapet wall used as signage, with the name of the store.

The main floor of the interior is divided into two main areas, the sales floor (4200 sq. ft.) which has a tile floor covering, and what was formerly the warehouse (3500 sq. ft.). The warehouse area of the main floor occupies the rear section of the building and features the old hardwood oak floors and wooden post and beam construction. It also contains interesting wooden display/storage lofts and enclosures that run along the southeast side of the building fronting Prince Street. This warehouse area has now been opened to the public as expanded retail floor space.

The basement extends below the original building (not the section added in 1951), and has a length of 133 feet and a progressive width that expands from 30 to 57 feet. The basement walls are cut sandstone and its ceiling structure contains the original components, including two steel H-beams (8"x 18") which run the length of the building, and steel crossbeams that are set on unusual 8 inch centers. This level was used as a stable for horses until 1946. The basement entrance is a set of wide double doors located on the east side of the building.

The building's interior has original wooden bins for seeds, bulbs, nails and other assorted items. The store walls still display metal signs for products from the ice and feed business from as far back as the 1930's.

The Beckley Feed & Hardware Company is eligible under Criterion A for Commerce. The period of significance begins in 1935 with the construction of the building and extends to 1951, for the new wing. Since the time period is so close to 50 years, Criteria Consideration G is not being used.

The company was organized in 1926 and was originally located about 200 yards away on Prince Street before moving to its present location in 1935. The building, located on the corner of Robert C. Byrd Drive and Prince Street, was designed by architect S.H. "Sam" Bridge, and was built in 1934 and 1935. Bridge was a prominent and highly respected architect in Raleigh County, having designed many buildings and homes in Raleigh and Fayette counties. He was the Supervising Architect on the former Federal Courthouse and Post Office in Beckley which was completed in 1933.

The construction of Beckley Feed & Hardware was of glazed tile block, and was typical for buildings of this era, especially those incorporating a warehouse facility. The interior still features wood construction with support beams.

The company's business comprised hardware, agricultural and feed supplies, and ice. As the only ice supplier in Beckley during the 1900's, an ice delivery day often lasted from 7:30 am until 10 pm. Large blocks of ice weighing 320 pounds and covered with a tarpaulin were delivered to homes and businesses throughout the county by horse and wagon. Smaller blocks were cut by hand from the large blocks with an ice pick at each customer's location, according to the amount of ice each needed. The store ran one main city route which was serviced by a larger wagon pulled by a two-horse team. It also sent out three separate single-horse wagons to service customers in the surrounding areas.

Since the ice obviously would melt on the wagons during the day, a relay truck was used to restock them. The truck was loaded with blocks of ice and then sent out to resupply the wagons at designated points along their routes. Of course, the advent of electricity and modern refrigeration eventually brought about the demise of the ice business, and Beckley Feed & Hardware ceased all ice deliveries in 1974.

Location near a railroad access was crucial to the hardware and agricultural business. Supplies were received two to four times per week of livestock feed, fertilizer, hay, straw, and other commodities vital to the lives and businesses of southern West Virginia. The primary loadout facility in Beckley, the location had a side-track next to the hardware store's main building, and a second side-track about 300 yards down the line for overflow supply cars. Raleigh County was once home to numerous farms and dairies, each of which were dependent upon the goods shipped to Beckley Feed & Hardware via the old C&O Railroad. Goods were delivered by rail until the 1970's.

Through the years the store held many retail promotions which are fondly remembered by older residents. One such incident in 1940 was the display of a very large, actual whale on a flatbed railcar on the store's side-track. It created a circus-like atmosphere as young and old came from miles around to see it.

A riot was nearly the outcome of "Free Chick Day" in 1938 when the store promised free baby chickens (limit 25) to all who came to the store. A mob of people surrounded the building that morning and crowded the doors such that they could barely be opened. Police had to be called in to contain the crowd.

Another retail highlight in 1946 was the "Ike and Mike" competition, which pitted two pigs against each other. One was fed Purina brand feed while the other ate an off-brand. Purina wanted to demonstrate to customers that their feed would fatten a hog better than any other brand. Their pig did win the competition and Beckley Feed & Hardware went on to sell a record-setting 5,600,000 pounds of Purina feed that year.

Increased sales led to the expansion of the sales area and the addition of a wing to the building in 1951. Typical of the architecture of the day, the front is comprised of horizontal glass windows with a center double door. Continued growth has expanded the retail sales area back into the former warehouse section, allowing the public to view and shop that part of the store with its oak floors, rafters, beams, posts and lofts.

The Beckley Feed & Hardware Company has been a mainstay in the community since 1926, and at its current location since 1935. The company has been a key supplier of goods and services vital to the success of the region's families, farms, dairies, and other businesses.

Historic Beckley feed store to be razed, replaced by a McDonald's

CHARLESTON, W.Va. -- A Beckley building that is on the National Register of Historic Places will be demolished soon and replaced with a McDonald's.

The Beckley Feed and Hardware building was built in 1935 and added to the National Register in 2001, the first year it was eligible. The business closed in June, as the building was slated to be sold to Paramount Development Corp., a real estate developer with offices in Beckley, Myrtle Beach, S.C., and Richmond, Va.

"The business was doing fine, and it was a successful business," said Austin Caperton, who has owned Beckley Feed and Hardware since 1998, "but I'm 62 years old, and somebody offered some money and I decided to move on."

Being added to the National Register is largely an honorary designation.

"Its main goal is to bring about a better appreciation for historic properties," said Paul Lusignan, a historian with the National Register. "There is no requirement under federal law that those buildings be preserved or protected."

When a building is added to the National Register, which is administered by the National Park Service, its owners are able to access certain state and federal grants and tax credits. If they use any of these funds, then there are restrictions to changing the building. Caperton never did, so he, and Paramount, are free to change the property as they wish.

The Beckley Code Enforcement Department approved the demolition and site plans on Oct. 1.

To be placed on the National Register, a building or site must be "significant in American history, architecture, archeology, engineering or culture." Nationally, there are about 87,000 listings in the Register, all of which were approved by a state review board. There are 1,041 listings in West Virginia, eight of which are in Raleigh County.

Twenty-four historic places in West Virginia have been demolished since 1972, according to a database compiled by the state Division of Culture and History.

Those include buildings like the Pocahontas Fuel Company Store in McDowell County, the Morgan County Courthouse, Parkersburg City Hall and the West Virginia Colored Children's Home, near Huntington.

Like most of the buildings on the list, nationally and in West Virginia, Beckley Feed and Hardware has a fascinating history.

The following information comes from Beckley Feed and Hardware's application, written in 2000, to be on the National Register:

The company began in 1926, but moved to its current location, on Prince Street, in 1935. A new wing was added to the building in 1951. As the name implies, they sold hardware and farming supplies, but in an age before refrigeration, they also delivered ice to homes and businesses throughout the city.

The only ice supplier in Beckley, the company sent out horse-drawn wagons carrying blocks of ice that weighed 320 pounds. At each house, smaller blocks were cut and chipped off by hand and sold to customers.

The company continued delivering ice, at least in some capacity, until 1974.

In 1938, police had to be called to the store as "Free Chick Day" nearly caused a riot. The store promised free baby chickens (limit 25!) to anyone who came by.

"A mob of people surrounded the building that morning and crowded the doors such that they could barely be opened," the application states.

In 1946, the store held a competition called "Ike and Mike."

Purina wanted to prove that its feed would fatten a pig better than competing brands. So it held an eating contest, pitting two pigs against each other, one eating Purina feed and the other eating a competitor's feed.

The Purina pig won, and Beckley Feed and Hardware sold a record-setting 5.6 million pounds of Purina feed that year.

Robert Cannon, the chief code-enforcement officer for Beckley, said there are still some issues to be worked out, relating to nearby sidewalks and sewers, before demolition of the store can begin. He expects work to begin soon.

Jerime Dudding, the development manager for Paramount, would not comment on the company's plans. McIlvried, DiDiano and Mox, a Pittsburgh engineering and surveying firm that is working with Paramount, did not respond to repeated requests for comment.

Caperton has donated the building's sign, original blueprints and other documents to the Beckley Historic Landmarks Commission.

"The best use of any viable historic building is to repurpose it and reuse it for a new business," said Scott Worley, the chair of the Landmarks Commission. "I really have misgivings anytime a developer or any entity decides to tear down a historic structure There's better purposes for that building. However, we have no say over the actions."
