The core commercial section of Glenville is built along two main perpendicular thoroughfares: Main Street and Court Street. Near the intersection of these two streets is the old Ruddell General Store, now the Country Store Museum.

The store sits on a lot 40 feet by 66 feet deep on a slight incline of the street. The building is approximately 30 feet by 65 feet being only slightly smaller than the lot it sits on. It is a two story, two bay, two-part commercial block plan of balloon frame construction. The two-part division reflects the differences in the use of the interior spaces. This wood framed constructed building has been covered for the past fifty years with brick patterned asphalt, or insul-brick siding, over original clapboard.

The first story storefront facade is original in material and design. The center glass entry is recessed and flanked by clear glass sidelights and transom. On either side of the entry are glass windows, full height with glass transoms running along the full width of the storefront and framed by a cornice overhang. Horizontal wooden paneling is located at the sill level. The windows on the second story were originally double-hung sash with 1/1 glazing. They were replaced in the 1970's by smaller aluminum framed, fixed sash glass windows. The cornice at the roof line is embellished with four evenly spaced Console or single vertical scrolled brackets. The windows on the side facade are 1/1 double- hung sash glazed windows and are original.

The lower street level interior space was originally used to house the store merchandise. Household goods, farm equipment and hardware supplies were also sold in the store. At the rear of the interior of the building on the first floor are a set of steps that lead to a mezzanine level. This area was used to display merchandise and for the store proprietor to have full view of the floor below. The rooms off the mezzanine, toward the rear of the building, were used as living quarters for the shop keeper. The upper, or attic floor, was used as storage for the overstock of goods.

While the exterior has been altered on the second floor, it is the interior space of the shop that stands out in this building. The decorative tin ceiling is still in place with side mouldings. The mezzanine has a decorative metal rail across the store; the rear doorway has a decorative turn of the century moulding with corner roundel blocks, and a low segmental arch with center block. One side of the store has built-in shelves for merchandise, and there are glass display cases and a wooden floor. The transom area over the display windows allows light into the rear of the shop as it was originally designed to do. In 1995, a bathroom was remodeled on the first floor in the rear of the store.

The Ruddell General Store has retained its integrity as a small general store in Gilmer County. Located in the commercial center of town, near the courthouse, the building was one of two general stores for the town of Glenville at the turn of the century. Its interior has survived intact despite many different commercial owners over the years.

The Ruddell General Store is being nominated under Criterion A for Commerce. The general store played a role as a community retail outlet during the early commercial development of Glenville at the turn of the century. As a retail outlet it continued to serve the area from 1890 into the 1970s. Its period of significance is recognized as 1890 to 1948.

Glenville is the county seat of Gilmer County, and as a regional business and commercial center has historically supplied a varied population with goods and services. In 1889, the town had a population of 400 and was increasing in size. The commercial center of Glenville continued to expand its services. Buildings for doctors and lawyers offices, barbershops and banks were being built and opened for business.

Stephen Lewis Ruddell (1818-1886) and wife Sarah Jane McMutchen moved to Glenville with their eight children from Craigsville, Virginia, in the early 1870's. Stephen L. Ruddell operated the Ruddell Hotel located on Main Street, in downtown Glenville. He also owned oil and gas interests throughout Gilmer County. Son, William Kerr Ruddell (1857-1940), seventh born of the eight children, went into the mercantile business and was involved in civic projects throughout Glenville much like his parents.

William Kerr Ruddell married Anna Yancy Eagon (1862-1905), daughter of Dr. Charles Eagon (founder of the Medical Department of the University of Virginia) in 1885. Anna and William had three children: Mildred, Mary Virginia and Charles Stephen.

Two years after their marriage, in April 1887, William Kerr Ruddell purchased a parcel of land from Mr. Oliver Cromwell McQuain for \$375. County court records report that work began on a building on this lot some time in 1890. Local carpenter and workman, Theodore Hauman, was hired to work on the construction of the building. William Kerr Ruddell opened his mercantile store soon after construction was finished. The store carried items such as dry goods and household items. Besides being a business owner, William Kerr Ruddell was an active participant in local civic affairs. He helped organize the Gilmer County Bank and Glenville Water and Light Company.

According to West Virginia State Gazetteers from 1889 to 1900, the Ruddell General Store was one of two listed general stores in Glenville. It was also one of only two general stores within a five mile radius of Glenville when it opened in 1890. The Ruddell General Store supplied much of the dry goods and household items needed for the growing community.

The store not only provided the citizens of Glenville with a place to purchase general merchandise and dry goods, but also a place for the patrons to gather to exchange news and gossip. As needs grew, so did the stores' merchandise. Washing machines, commercially packaged household cleaners, automotive parts, farming equipment, furniture and ready made clothing could be purchased at the store over the course of the years.

In 1916, William Kerr Ruddell moved to Parkersburg, West Virginia. The store was run by a Mr. William M. Moss and Mr. Van Arnold. The store was renamed the Arnold and Moss General Store and operated under this name from 1917 into the late 1920's. This store was still one of the only stores in Glenville to sell a variety of goods.

William Kerr Ruddell continued to own the building until his death in 1940, when it was then willed to his son Charles S., and daughter, Mildred R. Ruddell. The store continued to be listed among only a handful of other general merchandise stores in the State Gazetteers for the Glenville area.

During the 1930's through the 1950's, a Mr. Max Knackman ran a clothing store housed in the building. The building continued as a retail/commercial enterprise into the 1960's under various names selling a variety of items, but no longer as a dry goods and general merchandise store.

In 1973 Charles S. and Mildred R. Ruddell, children of the original owner, sold the building to the West Virginia Folk Festival, Inc. The Ruddell General Store was renamed the Country Store Museum. The West Virginia Folk Festival, Inc. organization opened a folk museum, library, and place in which to purchase local crafts and books on regional history.

Various general merchandise which was once sold at the store from 1890-1948 can be viewed from the museums' collection including weaving looms, musical instruments and household items. There are over two thousand artifacts, books and photographs depicting Appalachian culture on display at the store.

Summary:

For years, the Ruddell General Store was one of the few places in Glenville to supply the citizens with a place to purchase general merchandise and dry goods. The store also served as a place for the patrons to gather to exchange news and gossip. Although rented to various merchants, the store remained in the family hands for over 80 years. When the store finally closed, an organization, dedicated to preserving traditional regional ideals purchased the building and now provides a place to learn about the commercial history of the area. The interior of the store stands out as a timepiece of late 19th commercial design.

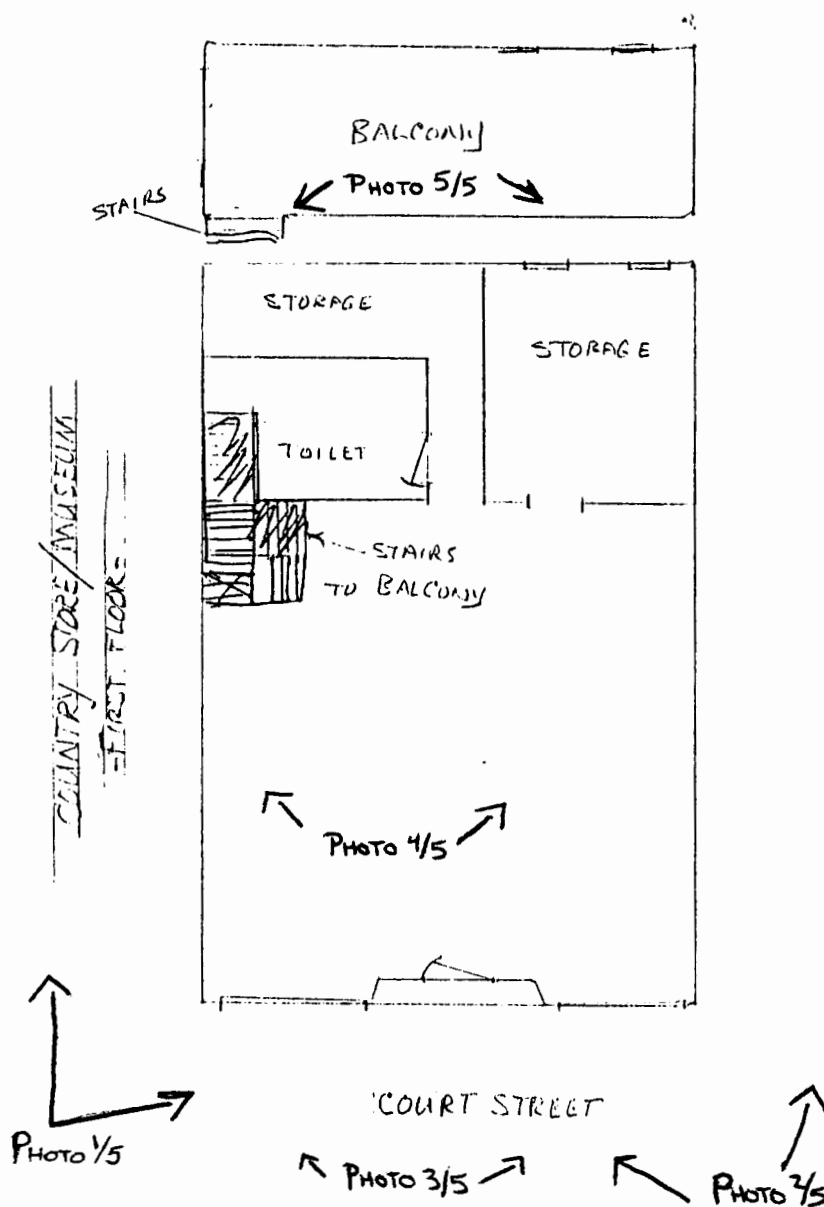

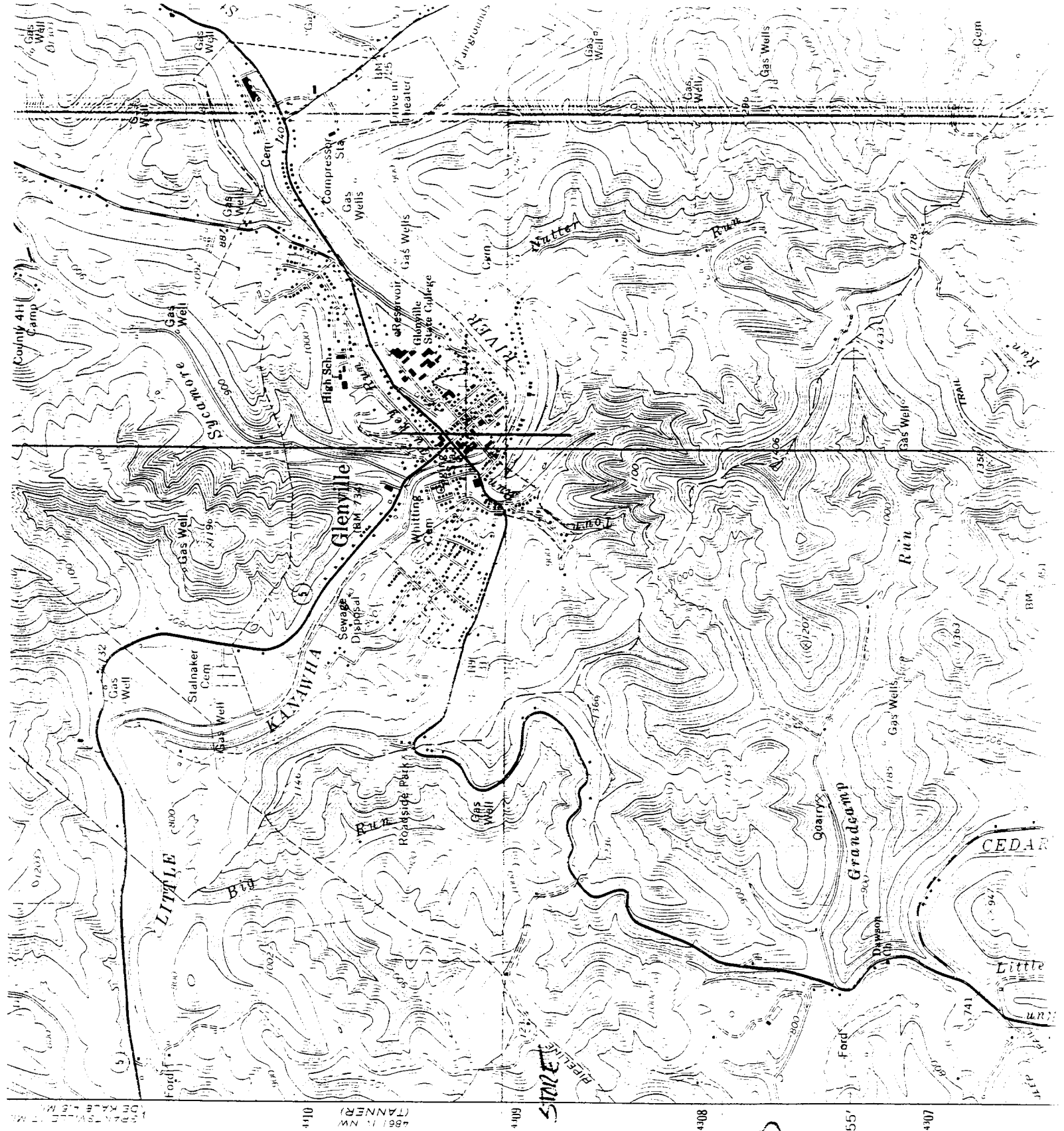
