Section number 1

Beall-Air was listed in the National Register of Historic Places on August 17, 1973. Section 1 of the nomination lists one "common name," "Beall-Air," and one "and/or historic" name, "Washington, Colonel Lewis, House." Sections 7 and 8 refer to the resource as "Beall-Air." In 2022, the Beallair Community Conservancy Inc. (BCC) contacted the West Virginia State Historic Preservation Office requesting that the spelling of the property be changed to "Beallair," removing the hyphen. This Additional Documentation seeks to clarify that the primary or "Historic name" under Section 1 should be "Beallair," while "Beall-Air" and "Washington, Colonel Lewis, House" be designated under Section 1 as "Other names."

Documentation provided by the BCC confirms that "Beallair" is the original spelling of the property. The earliest reference to the name is in a land deed made between Thomas Beall and Robert and Sarah Lucas on November 22, 1805, which refers to a "Thomas Beall tract known by the name Beallair." On January 16, 1845, Col. Lewis Washington advertised the sale of his estate in the *Virginia Free Press*, in which he spells the name "Beallair." Washington advertised the sale once again, using the same spelling, in the July 3, 1845 issue of the *National Intelligencer*.

The earliest known use of the spelling "Beall-Air" was in 1853, when the *Virginia Free Press* ran an article announcing Lewis Washington's sale of the property to an individual from Lancaster County, Pennsylvania (the sale may not have been finalized, as Washington continued to live there until his death in 1871).³ The hyphen may have been added to aid in the name's pronunciation.

The property has been spelled "Beallair" in more contemporary references. It was used by Don and Mary Jo Kennard, owners of the property between 1980-2004. The 2011 book *Uncommon Vernacular: The Early Houses of Jefferson County, West Virginia, 1735*-1835 by John C. Allen, Jr. uses this spelling. In 2004, the Wormald Corporation purchased the property and redeveloped part of the farmland into a private residential neighborhood. Both Wormald and the BCC (established to own and operate the property) use the spelling "Beallair."
