

2024 NAPC FORUM Conference Scholarship



The West Virginia State Historic Preservation Office (WVSHPO) is currently offering Conference Scholarships to attend the National Alliance of Preservation Commissions FORUM "Preservation Under the Palms" in West Palm Beach, Florida. The purpose of the scholarship program is to provide education on historic preservation issues to West Virginia residents by attending sessions, learning from examples, and networking with commission members from other states. Conference attendees will return to their communities with new perspectives and insights into advancing the historic preservation movement. Scholarships are open to members of <u>Certified Local Governments (CLGs</u>) within West Virginia.

Eligibility

Scholarships will be awarded on a competitive basis. Applicants associated with a Landmarks Commission with Certified Local Government status will have funding priority. Multiple commission members and staff from the same HLC may apply. Up to 10 scholarships will be awarded in total.

Applicants must demonstrate how they will be able to further local historic preservation efforts with knowledge gained from attending the conference.

Program Requirements

Scholarship recipients must agree to attend educational sessions at the conference. All scholarship recipients will also agree to provide either a photo essay or short article to be featured in WVSHPO's CLG newsletter. Either medium must focus on a single topic, session, or idea that you will bring back to your community. Essays/articles should be accompanied by a reimbursement request.

Eligible Expenses

Each applicant will be reimbursed up to \$1,500 for the NAPC FORUM for: **Lodging, registration, transportation to and from the conference, and additional conference tours and special event add-ons.** Meals and other expenses outside of the \$1,500 will be covered by the attendee or the HLC.

Registration: Please note the early bird registration deadline for NAPC

Before May 31st:

\$275 for NAPC members, \$325 for non-members

After May 31st:

\$300 for NAPC members, \$350 for non-members

Lodging: Conference room block rate is \$165 per night for general attendees in a single/double room at the <u>Hilton West Palm Beach</u>

Transportation: The easiest airport to fly into will be the Palm Beach International Airport (PBI). The scholarship will also cover fees for rides from the airport to the hotel and back at the beginning and end of the trip.

Reimbursement Procedures

No later than four weeks after the date of travel, the scholarship recipient will be required to return the reimbursement request, notification, receipts, and an essay/article as noted above in *program requirements*.

Reimbursement payments will be made by WV SHPO typically within four to six weeks after the request for reimbursement is received.

Selection Process

Applications will be selected according to the following criteria:

- How will participation assist in addressing a local issue(s)?
- Will the scholarship provide training to a novice or to an experienced person in the field of historic preservation?
- Will the scholarship allow travel to those with limited budgets, or to those who may otherwise not have attended?

Applicants who are awarded scholarships will be informed approximately two weeks after the scholarship submission deadline.
