Summary Paragraph

The Hutchinson-Parsons-Fulk Mail Pouch Barn is a circa 1940, wood frame, gambrel roof barn along Parkersburg Road in the rural, agricultural and residential community of Sandyville. It features two standard "Chew Mail Pouch Tobacco" advertisements, first painted on the barn in 1949. The signs have been repainted regularly over the decades. The barn remains in excellent condition, and both of its Mail Pouch signs are well-maintained. It meets the integrity requirements established in the "Mail Pouch Tobacco Barns of West Virginia" Multiple Property Documentation Form.

Narrative Description

The Hutchinson-Parsons-Fulk Mail Pouch Barn is a standard gambrel roof barn located along Parkersburg Road in the rural community of Sandyville. It is constructed with vertical wood planks, clad with a corrugated metal roof, and sits on a foundation of cut stone blocks. A small, vented cupola is located on top of the roof. On the barn's east side, facing Parkersburg Road, is an enclosed lean-to constructed of vertical wood planks and clad with a standing seam metal roof. Sliding doors on the west side provide access to the main interior of the barn. The lean-to is accessed by an opening on its south end and a door on its north end. The interior consists of a large open space with a loft above, and exposed wood planks and beams.

The west side, the eastern lean-to, and the cupola are painted red. The northern and southern sides of the barn feature identical painted Mail Pouch signs. Each sign reads "Chew Mail Pouch Tobacco, Treat Yourself To The Best." They are standard design Mail Pouch signs, with a black background, blue borders, "Mail Pouch Tobacco" in larger yellow text, and "Chew" and "Treat Yourself To The Best" in smaller, white text.

Photographic evidence indicates that in 1987 the phrase "Treat Yourself to the Best" was written on the barn in two lines, and was reconfigured to a single line following a repainting in the 1990s.¹ It is possible the one-line and two-line designs were used interchangeably on the barn during its Period of Significance (1949-1969), but this has not been confirmed.

Tax records suggest that the barn was constructed in 1940, which is in keeping with the barn's design, construction, and materials. The barn sits on the edge of a 189-acre parcel consisting largely of farmland, hills, and trees. To the barn's north and west are a gravel driveway, farmhouse, garage, and outbuilding.

The surrounding vicinity consists of hilly forestland divided by stretches of flat farmland, with Parkersburg Road (County Road 21) running through it. Along the road are many residential and agricultural buildings of varying ages, though most seem to date to the mid-to-late twentieth century.

The barn retains integrity of location, design, setting, materials, workmanship, feeling, and association. The barn has never been moved and has had minimal alterations or deterioration. While some newer residential development has occurred in the neighborhood, the area is still able to convey its rural, farm-centric setting. The Mail Pouch signs are in excellent condition, repainted by the owners on a periodic basis. With the possible exception of the "Treat Yourself" line, the colors, size, orientation, and font of both signs remain the same as they were historically.

Statement of Significance Summary Paragraph

The Hutchinson-Parsons-Fulk Mail Pouch Barn is eligible for the National Register on a local level of significance under *Criterion A: Commerce* and *Criterion C: Art*, in accordance with the requirements laid out in the Multiple Property Documentation Form “Mail Pouch Tobacco Barns of West Virginia.” The barn is significant under Criterion A for its association with Bloch Brothers Tobacco Company’s iconic barn sign advertising campaign. It is also significant under Criterion C as an important example of American folk art. The Period of Significance begins in 1949, the first year that a Mail Pouch advertisement was painted on the barn, and ends in 1969, when Bloch Brothers discontinued their barn sign advertising program.

Narrative Statement of Significance

Context for the history of Mail Pouch barns is provided in the “Mail Pouch Barns of West Virginia” Multiple Property Documentation Form (MPDF). As established in the document, the Bloch Brothers Tobacco Company embarked on a decades-long, multi-state advertising sign painting campaign. Using teams of painters, the company created thousands of signs, primarily on barns, imploring people to “Chew Mail Pouch Tobacco.” Throughout the mid-twentieth century, this was Bloch Brother’s primary marketing strategy for selling Mail Pouch chewing tobacco. The ubiquity of Mail Pouch barn signs across the rural American landscape and their production by a select few skilled painters led to them being regarded by many as a type of folk art. Of the thousands of Mail Pouch barns that once existed nationwide, very few remain. In West Virginia, less than 100 are believed to be extant.

During the mid-twentieth century, the barn and surrounding farmland belonged to the Hutchinson family. Around 1940, they constructed a wood frame barn next to Parkersburg Road. Also known as County Route 21, this road was a major throughfare in the region prior to the construction of I-77. The barn’s strategic location along an important local transportation route made it an ideal canvas for advertising.²

On May 7, 1949, Jack Hutchinson signed a lease to have two sides of his barn painted with 10’x30’ Mail Pouch advertisements. It was repainted for the first time on June 23, 1951, and further repaintings occurred over the next few decades. In 1961, the property was sold to Cecil Parsons. Chris and Russell Fulk purchased the property from the Parsons family in 1996 and remain the owners to this day.³

An advertising license tag (No. 76) found at the barn site had an expiration date of June 30, 1957. The company listed on the tag was Mail Pouch Tobacco Co., one of the entities used by Bloch Brothers to lease barn signs. In 1979, this barn became one of 44 in West Virginia exempted from the regulations of the Highway Beautification Act of 1965, since its creation predated the act’s passage.⁴




Figure 1 USGS Map - Sandyville Quadrangle, West Virginia - Jackson County - 7.5-Minute Series, 2023




Figure 4 Barn in 1987, with two-line "Treat Yourself" phrase. Image obtained from Mail Pouch Barnstormers.
